Metinde ayrıca, ihaleye ilişkin olarak 28-29 Temmuz 2015 tarihlerinde Banjul'da ihale öncesi bir toplantı ve yerinde ziyaret programı düzenleneceği, katılmak isteyenlerin 20 Temmuz tarihine kadar katılımlarını teyit etmeleri gerektiği, söz konusu ihalelerle ilgilenebilecek Türk firmalarının ayrıntılı bilgi edinmek için doğrudan GAMWORKS ile temasla gecebilecekleri ifade edilmektedir.


