That by the Law 24.425 approving the Final Act Embodying the Results of the Uruguay Round of multilateral trade negotiations, decisions, declarations and ministerial understandings and the Marrakesh Agreement, which established the WORLD TRADE ORGANIZATION (WTO).

That among the agreements contained in Annex 1A to the Marrakesh Agreement is the Agreement on Procedures of Licensing.
