Regarding the holding of hearings

The Department of Foreign Economic Activity and Trade Protection of the Ministry of Economy, within the framework of an anti-dumping investigation into the import of fresh cucumbers and fresh tomatoes originating in the Republic of Turkey into Ukraine (hereinafter referred to as the investigation), hereby informs.

In connection with the military aggression of the Russian Federation against Ukraine, based on the proposal of the National Security and Defense Council of Ukraine, in accordance with Clause 20 of Part One of Article 106 of the Constitution of Ukraine, the Law of Ukraine "On the Legal Regime of Martial Law", Decree of the President of Ukraine dated February 24, 2022 No. 64/2022 "On the Introduction of Martial Law in Ukraine", approved by the Law of Ukraine dated February 24, 2022 No. 2102-IX, as amended, martial law has been introduced in Ukraine.

In view of the above, public hearings in the format of face-to-face meetings between representatives of the Ministry of Economy and interested parties to the investigations are temporarily canceled. Instead, the Ministry of Economy will take measures to organize a remote format for exchanging opinions/positions of interested parties in order to ensure the exercise by the parties of the right to protect their interests in accordance with the provisions of the Law of Ukraine "On Protection of National Producers from Dumped Imports" (hereinafter referred to as the Law).

The information basis for conducting investigative hearings is the position papers of interested parties, which are working materials provided by interested parties for the purpose of preparing other interested parties for the hearings.

Based on this, the Ministry of Economy proposes that, if an interested party has any arguments, information and evidence related to the investigation (hereinafter referred to as positional materials), no later than 16.01.2025 by 18:00 (Kyiv time), provide all interested parties with access to their positional materials exclusively by uploading their non-confidential versions to the "Positional Materials" folder in the personal viewing account "AD_ovocho" (<http://surl.li/geefix>) on cloud storage (Google Drive).

Counterarguments to the position papers of other interested parties, if any, must be submitted to the Ministry of Economy in writing, and all interested parties must be provided with access to them by uploading their non-confidential versions to the "Counterarguments" folder on the cloud storage, no later than 23.01.2025 by 18:00 (Kyiv time). Please note that in accordance with Article 13 of the Law, information

presented during the hearings will be taken into account in the investigation process, provided that it is submitted to the Ministry of Economy in writing and sent to all interested parties to the investigation, taking into account the requirements of Article 32 of the Law. The non-confidential summary of such information must be so detailed that the essence of the confidentially transmitted information is clear. The Ministry of Economy will continue to take measures to maintain the level of transparency and ensure the exercise by interested parties of the right to defense in trade investigations.
