The roads are as follows:

(A) Agricultural Roads

1. From Ikwoto Town to Imotong, Himodonge to Torit Town (83 km) ✓
2. From Momoria Junction to Isohe and to Lobira Junction (35 Km).
3. From Lofi Junction to Lolit and Isohe Junction in Lototo (18 Km).
4. From Himodonge road to Hatire (45 Km)

(B) Security Roads

1. Chahari to Faraksika Junction joining Chukudum road (25 Km).
2. Ramula, Tufe to Chukudum junction (30Km) ✓
3. Lobira road to Ramula Junction (40 Km)
4. Otome road to Bira (73 Km)
5. Lotome, Lofus to Tseretenya (68 Km)



C) High way Roads

11. Hiyala - Ikwoto high way road (64 Km) ✓
12. Ngaluma road to Agoro of Uganda (25 Km)


